A. Co-curricular advisors: This category is co-curricular in nature and is an extension of regular class activities. Any supplementary pay received must be considered to be in addition to receiving a regular salary for teaching a regular class during the school day. The additional pay would be for additional time as required and for some additional responsibilities.

All approved club advisors are to receive pay.

B. Teachers will be given an opportunity to co-curricular duties in Appendix B.

Factored supplementary assignments will receive extra pay as follows:

Base Salary is the salary for Class I, Step I of the teacher's salary schedule for the 2019-2020 school year and will be paid to the teacher serving the first year in the factored position.

Beginning in the 1985-86 school year, for each year of experience in the position at Brawley Union High School in the Supplementary Assignment the factored position will advance one step of Class I on the teachers' salary schedule until reaching the fourth step of Class I.

Stipends for co-curricular assignments will be paid as provided in Appendix B-1 Co-Curricular Pay Schedule and will be paid only for authorized service. Service is authorized when the District and the employee have agreed and the Board of Trustees has approved the assignment.

Compensation will be prorated if the employee starts after the prescribed beginning date or if service is terminated prior to completion of the school year.

Eff 7/1/2020, Clubs must be approved by Administration on September 1 and by AB on September 5 for the full year stipend (September to June). Club Advisor approval after this timeline will be for a pro-rated stipend effective in the month of Board approval. Teachers will be limited to one Club Advisor assignment per year unless Administration approves a second under special circumstances.

For all other Appendix B-1 Co-curricular Assignments (other than Club Advisor), Administration will make selections based on unit member responses to criteria established for the assignment and included in the original announcement for the position.

If a unit member does not apply, the District may advertise and hire a non-unit member based on a fair and equitable process according to the District's established selection and hiring procedures.
